V. NEW BUSINESS

A. Discussion & Possible Action re: Proposed Capital Projects Expenditure – retiring apparatus debt transferring from Wittmann Fire & Medical District

As a result of the recent consolidation between North County and Wittmann Fire & Medical Districts, the District assumes all liabilities for Wittmann Fire & Medical District. Staff reviewed for the Board their request for authorization to notify the lien holder for the debt related to the Wittmann Fire & Medical District's 2012 E-1 E-max pumper on or before November 15, 2016 regarding the District's intent to

retire this debt utilizing Wittmann Fire & Medical District available capital funds. Staff answered any questions from the Board related to this item.

Board Clerk Smith moved that the Board notify Tax-Exempt Leasing Corporation regarding the District's intention to retire the debt related to Wittmann Fire & Medical District's 2012 E-1 E-max Pumper for an amount not to exceed \$300,000. Board Member Meyer seconded the motion.

B. Discussion & Possible Action re: Existing Wittmann Fire & Medical District Fire Chief's Contract

Chief Biscoe related to the Board that it was necessary for the Board to terminate the Wittmann Fire & Medical District Fire Chief's contract as the position no longer exists following the consolidation of North County and Wittmann Fire & Medical Districts. Chief Biscoe informed the Board that it is the District's intention to retain the former chief in the position of Division Chief/Fire Marshal for North County Fire & Medical District. Chief Biscoe answered any questions from the Board.

Board Member Meyer moved that the Governing Board authorize the termination of Tom O'Donohue's Wittmann Fire & Medical District Fire Chief contract dated November 1, 2015, as the position has been eliminated following the consolidation of Wittmann and North County Fire & Medical Districts. Board Clerk Smith seconded the motion.

Chiefs Biscoe and Dalton answered any questions related to the consolidation.
